

## The LMFx Golden Draw Terms and Conditions

### 1. Introduction

The LMFx Golden Draw Terms and Conditions shall be read together with the Company's "Terms of Business" and "Account Opening Agreement" and it is considered an annex of all the information included in these two documents. The Golden Draw (henceforth The Draw) is available for all Clients who have successfully opened, verified and funded their account with the Company per the "Account Opening Agreement".

Participation in The Draw is granted automatically to everyone who has made a successful registration, has verified their KYC documents, has deposited a minimum of 2,000 USD/EUR depending on the wallet's main currency and has managed to trade at least 20 standard lots throughout The Draw year on their live account/s.

Participation is open to both existing and future clients.

### 2. Participation

Enrollment in The Draw is done automatically for eligible participants and does not require any additional opt-in beyond fulfilling the initial requirements as mentioned above. There are no downsides to participating in The Draw, but clients who do not wish to participate may send a request to [support@lmfx.com](mailto:support@lmfx.com) to be excluded from the drawings and to discuss any relevant questions or concerns.

The Draw will run from The first of May (01.05) until April 30th of next year (30.04). For subsequent years where the dates fall on weekends the start day will be the first work day of May and the end date will be set as the last work day of April the following year.

### 3. Conditions of participation

- 20 Forex traders will be drawn randomly and will win a 50-gram 24 carat gold bar (or its dollar equivalent) at the end of each Draw year.
- Additionally, for every extra 10 lots traded on top of the initial 20 required, the trader will also increase their odds of winning.
- Internal transfers do not count towards the live account deposit amount.
- Only trades that last more than 1 minute are counted towards the contest.
- Only trades that have a difference of at least 5 pips between open and close price count toward the contest.
- Micro trading accounts are excluded from The Draw.
- The trading requirements for each client are based on the combined number of lots traded on all their live accounts for the period.
- The winners will be drawn at the end of the promotion and will be listed on a designated page on the LMFx website. Additionally, winners will be contacted via email or phone within 3 days of the winner announcement to specify if they wish to receive a physical gold bar or its cash

equivalent instead. If a Client decides to receive a cash equivalent the amount will be available in the client's LMFX wallet and it will be allowed for trading or withdrawal at any time.

- Clients may not open additional LMFX wallets or participate with corporate accounts in an attempt to win multiple prizes or artificially increase their odds of winning.
- Only one prize can be given to any one single household. Additionally, IP addresses and documents will be monitored for people sharing a single device/connection.

#### 4. General Terms

Partners are allowed to participate in The Draw when trading from their live account(s).

The Company has the right at any time to amend or terminate the “Golden Draw Terms and Conditions” or any part of The Draw without prior notice. Such changes will be announced on the Company's website. It is recommended that the Client consults these Terms and Conditions regularly.

These Terms and Conditions are governed by and construed by the laws of the Republic of North Macedonia. Any conflict or situation not described in this document will be amicably resolved by the Company management.

The Client acknowledges that Forex and CFDs are leveraged products that involve a high level of risk. When trading such products, the client can lose all their capital. These products may not be suitable for everyone and Client should ensure that he understands all the risks involved.
